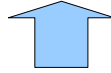

## Proposed Corporate Re-Structure

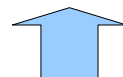
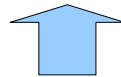
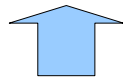
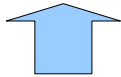
### President – CEO

Chief Financial Officer of -DARK responsible for managing the financial risks of the corporation as a whole. This executive is also responsible for financial planning and record-keeping.	Chief Operating Officer of -DARK, responsible for managing the day-to-day activities of the corporation. The COO is one of the highest ranking members of the organization, monitoring the daily operations of the company and reporting to the President directly.	Chief Industrial officer, responsible for all Industrial issues within -DARK, including but not limited to Ship Production & Internal Corporate Industrial Structures and facilities.	Chief Logistics Officer, responsible for all logistical issues within -DARK, including but not limited to movement of Armed Forces, maintenance of the Fleet & Corporate Structures. Responsible for the acquisition and sale of products and minerals.

Responsible completing all tasks relating to the financial well being of -DARK, in accordance with the guidance of the CFO, responsible for overseeing all financial transactions that take place within the corporation, keeping records and reporting back to the CFO. Responsible for all Finance Clerks within the organisation.	Responsible for leading -DARK fleets at times of Combat or War. Responsible for ensuring that the Fleet is set up appropriately, assessing the enemy on the job. Ensuring unnecessary financial loss to -DARK is not inflicted. Responsible for ensuring that Kill boards accurately reflect battles under their command. Responsible for the ongoing training of all members of the Fleet. Reporting directly the COO.	Responsible for overseeing all requests for production within -DARK. Having a full understanding of all -DARK controlled factories, assessing mineral levels regularly and reporting back the CIO. Responsible for supervising the activities of all Industrial Operatives within the organisation.	Responsible for the overseeing of all task relating to the logistical well being of -DARK. Ensuring that all operational needs are met within the corporation and feeding back issues directly to the CLO. Supervising the movement of company assets and ensuring enough resources are available at all times to meet corporation needs. Responsible for all Logistical Operatives within the Organisation.

Working closely with Industrial and Logistical operatives to ensure -DARK has sufficient numbers of ships to meet current demands. Supervising the conduct and induction of all Ensign grade pilots within the organisation. Reporting back to the Captains.	Responsible for assessing current requests for production & mining, completing them and informing all parties involved when Job is completed. Responsible for keeping organised records on the forums and supervising payments for company assets where necessary. Reporting back to the Industry Manager	Responsible for moving -DARK assets in accordance with requests from the Logistics Managers or from the CLO directly. Ensuring that sufficient Industrial Vessels are available at all times. Supporting Industrial Operatives with fulfilling requests of the corporation. Reporting back to the Logistics Manager
Ensign/Lieutenant Junior Grade [Lvl1 / 2]			
Responsible for maintaining own financial well-being whilst a member of -DARK.. Ensuring a ship of all standard grades is maintained for PVP purposes at all times. Actively becoming involved with any corporation activity where needed as directed by the presidency's wishes.
